OFFICE ORDER


On the recommendations of the Departmental Screening Committee and in pursuance to the Govt. letter No. PER(AP)C-B(2)-1/2014-V-II dated 30.04.2023 and consequent upon completion of two years continuous service on contractual basis, the services of **Km Anu Negi D/o Sh Raj Deepak Singh Negi, line men Quarter, Shankli Lakkar Bazar GPO Shimla, Village up mohal Kalibari, Tehsil Shimla Urban, Distt. Shimla** is hereby regularized to the post of **Computer Operator** in the initial pay of ₹ 35,600/- (level 9 Cell 1) as per HPCS (RP) Rules, 2022 with immediate effect and posted in the office of **District Welfare Officer, Kullu Distt. Kullu H.P.**

Consequent upon her regularization she will now also be entitled to draw dearness and other allowances at the rates admissible and subject to the conditions laid down in rules /orders governing the grant of such allowances in force from time to time.

1. The terms of appointment are as under:-

- (i). The appointment is temporary and will not confer any title of permanent employment.
- (ii). The services of the appointee may be terminated at any time by a month notice given by either side viz, the appointee or the appointing authority without assigning any reasons. The appointing authority, however, reserves the right to terminate the services of the appointee forthwith or before the expiry of the stipulated period of notice or the unexpired period thereof.
- (iii). The appointment carries with it the liability to serve in any part of Himachal Pradesh, and will have to serve in Tribal/Difficult area for a minimum tenure of five years under Difficult Area Sub Cadre.
- (iv). Other conditions of services will be governed by relevant rules and orders in force from time to time.

2. The appointment will be further subject to:-
- (i). Production of certificate of fitness from Chief Medical Officer/ Civil Surgeon.
 - (ii). Submission of a declaration to the effect that she does not have more than one living husband in case she is married.
 - (iii) Taking of an oath of Allegiance/faithfulness to the constitution of India or making solemn affirmation to that effect.
 - (iv) Her character and antecedents are found satisfactory.
 - (v) She will be on probation for a period of 2 years from the date of joining the post
3. If any declaration given or information furnished by her proves to be false or if she is found to have willfully suppressed material information, she will be liable for removal from service and to such other action as Government may deem fit and necessary.
4. If the offer of appointment is accepted to the Candidate on the terms and conditions mentioned above, she may report for duty in the office of the **above mentioned office, within 10 days of the issuance of this order** otherwise the offer shall stand cancelled.
