The Governor, Himachal Pradesh is pleased to make the following rules regarding "Follow-up-programme" to Scheduled Castes in Himachal Pradesh:

THE HIMACHAL PRADESH FOLLOW UP PROGRAMME RULES 1574.

TITLE :

1, These rules shall be called the Himachal Pradesh Follow-upprogramme Rules, 1974.

SCOPE AND COMMENCEMENT.

2. These shall extend to the whole of Himachal Pradesh and shall come into force with effect from the date of their publication in the Officeal Gazette of the State.

DEFINITIONS :

- 3. In these rules, unless the context otherwise requires :-
- (a) "annexure" means annexure to these rules.
- (b) "Committee" means District Welfare Committee or the District Planning and Development Committee as the case may be.
- (c) "Director" means the Director of Welfare of Himachal Pradesh.
- (d) "Government" means the Government of Himachal Pradesh, and;
- (e) "Scheduled Caste" means the castes, races or tribes or parts or group Within castes, races or tribes specified in the Constitution (Scheduled Castes) order, 1950, as amended by section 19(1) read with the First Scheduled of State of Himachal Pradesh Act, 1970 (53 off 1970) and as it may further be amended from time to time.

"Deputy Commissioner" means Deputy Commissioner of the district.

"Antodya families" means every families identified of such under Antodya Programme.

ORDER OF REFERENCE FOR THE GRANT OF SUBSIDY.

- 4.(1) The subsidy under these rules shall be given to the Scheduled Castes and families identified under Antodya Proframme in the following order of preference.
 - (i) Persons who have got diploma or certificate from the institution recognised by the Government.
 - (ii) Persons who have received regular training in the centres run by the Voluntary Organisation but have not been awarded any certificates or diploma by such centre;
 - (iii) Persons who are well conversant with the trades but have not received any training from any such institution as such.

"Provided that in the case of persons falling under category Extense (ii) the recommendations of the Heads of Institution shall be necessary so that the District Welfare Officers may be in a position to

verify their cases properly. Provided further, that in the case of persons falling in category (iii) a certificate will be required to be given by the respective District Industries Officer or Distt. Welfare Officer or the Block Development Officer, to the effect that the applicant is well conversant with the trade/profession."

PROCEDURE TO BE OBSERVED.

- The Distt. Welfare Officer shall obtain applications from the deserving caseson prescribed form in Annexure "A". On receipt of such applications, the District Welfare Officer shall examin the question of grant of subsidy to the applicants in the light of funds placed at disposal for the purpose during the year. He shall than place such casesbefore the Distt. Welfare Committee for their approval and forward the same alongwith certificates as prescribed in Rule 6 for obtaining sanction of the Deputy Commissioner."

- (iii) The condition of test aspen provided in sub-rule (ii) shall be relaxed in deserving cases for the grant of sub-sidy provided the Selection Committee is satisfied that such a test is not necessary for the reasons to be recorded in writing".
- 6. The District Welfare Officer, at the time of sending proposals, shall furnish the following cartificates:-

- (ii) that the proposed bereficairy/beneficiaries is/are bonafide resident of Himachal Pradesh and belong to Scheduled Castes.
- (iii+ that the list/listsof proposed beneficiary/beneficiaries is/are kountitiexxxxxid has/have been approved by the Distt. Committee.
- (iv) that the proposed beneficiary/beneficiaries is/are has/have not received similar benefit hereto-fore.
- (v) that the annual income of each beneficiary does not exceed Rs.6,000/-per annum.
- (vi) that the tools/equipments etc. will be of approved model/specifications and after accounting for the subsidy belance shall be paid by the beneficiary/beneficiaries.

- that the subsidy shall not be misutilised by the beneficiary/ (vii) beneficiaries.
- (viii) / that the beneficiary/beneficiaries is/are agreeable to execute bond on the form at annexure "B".
- (ix) that the subsidy shall be given in kind and not in cash.
- 7. After the receipt of sanction the tools/equipments shall be purchased by the Committee consisting of following members :-
- (i) Deputy Commissioner Chairman. (ii) District Industries Officer Member.
- (iii) District Welfare Officer Member Secretary.
- (iv) A public representative Coopted member.

The subsidy shall be paid in kind and not in cash. The tools equipment shall be of such make/model as may be approved by the above committee. The quorum of Committee to conduct the meeting and to take decisions shall not be less than three.

- 8. QUANTUM OF ASSISTANCE.
- xkx The quantum of assistance shall be as follows :-
- i) Carepentary Blacksmith tools up to Rs.500/- per beneficiary. Weaving and spinning tools. Rs.500/-
- ii) iii) 11
- iv) Leather work equipment. Rs. 500/- "
- 9. The District Welfare Officer shall himself visit at least 25% of the beneficiaries to whom subsidy was given and shall ensure that the tools/equipmentsare being used for the purpose for which these were granted, and the terms and conditions of the bond are being followed strictly. In the remaining 75% cases physical verification of the tools/equipments would also be done by the representative of the Welfare Department/Committee so authorised by the Director of Welfare. Cases of breach shall be immediately reported to the Director of Welfare with suggestion, for affecting recovery from the defaulters.
- The beneficiaries shall make available the tools equipments for inspection by the Director of Welfare/ District Welfare Officer comerned or their representatives as and when they demand.

MAINTENANCE OF RECORD.

The District Welfare Officer shall maintain registers and send 11. returns to the Director of Welfare as may be prescribed by the Director from time to time, and shall also produce the same before the audit party, if and when so required. Utilisation certificates shall be furnished by the respective District Welfare Officer immediately after the distribution of tools/equipments to Director of Welfare who will furnish the same to the Audit and Accounts Department under intimation to the sanctioning authority. Copies of such utilisation certificates shall be retained in the office of the respective District Welfare Officer for record. The District Welfare Officer shall also submit the comparative statement alongwith the quotations invited for purchase of equipments/tools. The tools will be purchased for the lowest tenderer.



ANNUAL RETURN.

The District Welfare Officer, at the end of each financial year, shall send a narrative report to the Director of Welfare indicating the funds utilised, persons benefitted tools/equipment purchased, name of the supplier(s) from whom tools/equipments are purchased, and other such particulars required by the Director. The Director of Welfare thereafter, shall the consolidated report of the entire Pradesh to the Audit and Accounts Officer as also to be Administrative Department.

The District Welfare Officer shall also submit annual return to the Director in a form at annexure "C" giving beneficiaries details.

GENERAL:

13. In case where the Director is satisfied that subsidy under the scheme has been granted to an ineligible undererving person or that the beneficiary has secured it by fraudulent means be shall have the right to recover from the beneficiary, the whole or any part of the subsidy as he may determin as arrears of land revenue. In such cases the Director of Welfare Officer for not making inquiry properly before recommending the name to the Committee for the grant of subsidy and shall take suitable action against him under intimation to the Administrative Department.
