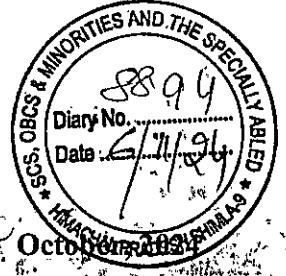

Hon'ble Court of Himachal Pradesh vide order dated 21.10.2024 in COPC No. 235/2024-titled as Chaman Lal & Others V/s Ashish Singhmar has directed as under:-

“On the request of learned Advocate General, list on 18.11.2024, as he assures the Court that by the said date, until and unless, there is a stay granted in the case by the Hon'ble Supreme Court in the Special Leave Petition, that is being preferred by the State, the judgment in question be implemented subject to all legal rights of the respondents”.

In order to comply the aforesaid mentioned order of the Hon'ble Court, the Department vide letter No. SJE-B-B015/2/2023-119985 dated 23.10.2024 has decided to initiate the process of implementation of order dated 28.09.2023 passed in CWPOA No. 1745/2020- titled as Chaman Lal & Others V/s State of H.P. and therefore accordingly final seniority list as circulated vide letter No. SJE-B-B015/2/2023 dated 01.02.2024 is to revised at first instance.
