Consequent upon their regularization he/she will now also be entitled to draw dearness and other allowances at the rates admissible and subject to the conditions laid down in rules /orders governing the grant of such allowances in force from time to time.

1. The terms of appointment are as under:-

- (i). The appointment is temporary and will not confer any title of permanent employment.
- (ii). The services of the appointee may be terminated at any time by a month notice given by either side viz, the appointee or the appointing authority without assigning any reasons. The appointing authority, however, reserves the right to terminate the services of the appointee forthwith or before the expiry of the stipulated period of notice or the unexpired period thereof.
- (iii). The appointment carries with it the liability to serve in any part of Himachal Pradesh, and will have to serve in Tribal/Difficult area for a minimum tenure of five years under Difficult Area Sub Cadre.
- (iv).Other conditions of services will be governed by relevant rules and orders in force from time to time.
- 2. The appointment will be further subject to:-
- (i). Production of certificate of fitness from Chief Medical Officer/ Civil Surgeon.
- (ii). Submission of a declaration to the effect that they do not have more than one living husband/wife in case they are married.
- (iii) Taking of an oath of Allegiance/faithfulness to the constitution of India or making solemn affirmation to that effect.
- (iv) His/Her character and antecedents are found satisfactory.
- (v) He/She will be on probation for a period of 2 years from the date of joining the post
- 3. If any declaration given or information furnished by him/her proves to be false or if he/she is found to have willfully suppressed material information, he/she will be liable for removal from service and to such other action as Government may deem fit and necessary.

4. If the offer of appointment is accepted to the Candidate on the terms and conditions mentioned above, he/she may report for duty in the office of the above mentioned office, within 10 days of the issuance of the order otherwise the offer shall stand cancelled.
