Sir,

Kindly refer to this Directorate letter of even No. 5th May, 2017 vide which all the concerned Departments to the Government of Himachal Pradesh has been requested to implement the provisions of the 'Rights of Persons with Disabilities Act, 2016. It has been brought to the notice of this Department through some media reports that the Department of Education has not yet been taken any action to implement the provisions of Section 32 (1) of the Rights to Persons with Disabilities, Act 2016 even though the Act stands implemented w.e.f. 19th April, 2017 in the State of Himachal Pradesh.

Section 32 (1) of the Act mentioned reproduced as under:

All Government institutions of higher education and other higher education institutions receiving aid from the Government shall reserve not less than five percent seats for persons with benchmark disabilities.

In this regard, you are requested to kindly refer the matter to the Department of Education to do the needful in the aforesaid matter at the earliest please.


