NOTIFICATION

The Governor, Himachal Pradesh is pleased to make the following rules further to amend the Himachal Pradesh Grant of Housing Subsidy to Backward Classes Rules, 1975 notified vide this Department's notification No. 22-2/69-Vol-II-Wel. Sectt. dated the 22nd August, 1975 published in the Rajpatra on 20.09.1975, namely:-

Short title and commencement:

- (1) These rules shall be called the Himachal Pradesh Grant of Housing Subsidy to Backward Classes (11th Amendment) Rules, 2012.
- (2) These rules shall be deemed to have come into force with effect from the date of issue of this notification.

Amendment of proviso of Rule 7 Rule 7

In the proviso to rule 7 of the HP Grant of Subsidy to Backward Classes Rules, 1975, the figure of Rs. 29,330/-:

In item (d) below the rule 7 figure of Rs. 10,000/-;

Shall be substituted as under :-

The amount for grant of housing subsidy for construction/repair of houses to the SCs/STs and OBCs shall be provided by the Department at the rates fixed from time to time.
