**NOTIFICATION**

The Governor, Himachal Pradesh, in pursuance of the provisions contained in HP Grant of Housing Subsidy to Backward Classes (Tenth Amendment) Rules, 2005 is pleased to enhance the housing subsidy for construction of new houses from existing limit of Rs. 38,500/- to Rs. 48,500/- per unit being provided to SC's/STs and OBC's.

2. This enhancement is subject to the condition that no additional budget will be provided for the current financial year 2010-11.

3. This issues with the prior concurrence of the Finance Department obtained vide their Dy. No. 51492663-Fin (A) 6/95 dated 15th July, 2010.

4. This supersedes this Department's notification Number WLF-B-A (3)-3/2000 dated 30th December, 2008.

The Governor, Himachal Pradesh is pleased to make the following rules further to amend the Himachal Pradesh Grant of Housing Subsidy to Backward Classes Rules, 1975 notified vide this Department's notification No. 22-2/69-Vol-II-Wel. Sectt. dated the 22<sup>nd</sup> August, 1975 published in the Rajpatra on 20.09.1975, namely:-

- Short title and commencement:
- (1) These rules shall be called the Himachal Pradesh Grant of Housing Subsidy to Backward Classes (11<sup>th</sup> Amendment) Rules, 2012.
  - (2) These rules shall be deemed to have come into force with effect from the date of issue of this notification.

Amendment of proviso of Rule 7  
Rule 7

In the proviso to rule 7 of the HP Grant of Subsidy to Backward Classes Rules, 1975, the figure of Rs. 29,330/-:

In item (d) below the rule 7 figure of Rs. 10,000/-;

Shall be substituted as under :-

The amount for grant of housing subsidy for construction/repair of houses to the SCs/STs and OBCs shall be provided by the Department at the rates fixed from time to time.
